Board Meeting

The meeting was called to order at 1:30 p.m.

Suggestions for new BIA board members

The current board consists of 12 members (Jeff Powers resigned). Bob Anderson and Ken McDonald (to be confirmed) agreed to be reelected to a third term. Jim Jones decided to exit the board after the current term, leaving the board with 11 members.

By laws require between 9 and 15 board members. We would like to get to the maximum. The current bylaws limit board members to 3 terms. The following persons were put forward as potential candidates.

Mark Engelsman discussed a BICS PTA project to guarantee financial support for all students who successfully complete BICS high school graduation (similar to the Kalamazoo Project). Bob Anderson mentioned that at least 2 scholarship funds already exist (at the Charlevoix County Community Foundation). Mark will provide more information as the project develops. The Board should determine what role the BIA might undertake in this endeavor.
